F No. 8(1)/2016/L&B/LA/ 7/11 : In the exercise of the powers conferred by sub rule (1) of rule 4 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact, Assessment and Consent) Rules, 2014, read with Government of India, Ministry of Home Affairs Notification No. S.O. 2740(E) dated 21<sup>st</sup> October 2014, read with S.O. 2004 (E) dated 21<sup>st</sup> July 2015, the Lieutenant Governor of National Capital Territory of Delhi, is pleased to assign the Indian Institute of Public Administration, Indraprastha Estate, Ring Road, New Delhi 110002 which was identified as Social Impact Assessment Unit vide Notification No. F8/2/9/2015/L&B/LA/2373 dated 13<sup>th</sup> June 2017 to carry out Social Impact Assessment Study and to prepare Social Impact Assessment report for acquisition of land, which the Delhi Police intends to acquire land for public purpose for construction of Police Station Sonia Vihar, Delhi in the revenue estate of village Sabhapur, Shahdara.
