

No. 8(2)/16/2015/L&B/LA/ : In the exercise of the powers conferred by sub rule (1) of rule 4 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact, Assessment and Consent) Rules, 2014, read with Government of India, Ministry of Home Affairs Notification No. S.O.2740 (E) dated 21st October 2014, read with S.O. 2004 (E) dated 21st July 2015, the Lieutenant Governor of National Capital Territory of Delhi, is pleased to assign the Indian Institute of Public Administration, Indraprastha Estate, Ring Road, New Delhi 110002 which was identified as Social Impact Assessment Unit vide Notification No. F 8/2/9/2015/L&B/LA/2373 dated 13th June 2017, to carry out Social Impact Assessment Study and to prepare Social Impact Assessment report for acquisition of land, which the Delhi Jal Board intends to acquire land for public purpose for construction of Waste Water Treatment Plant at Tajpur Khurd revenue estate of South -West revenue district.
