Minutes of Meeting

Minutes of the Meeting of Search Committee held on 27.02.2026 to shortlist applications for the post of Member of the Real Estate Regulatory Authority for NCT of Delhi and UT of Chandigarh.

Venue: In the Conference Room of Pr. Secretary (Vig.), 4th Level, C-Wing, Delhi Secretariat, I.P. Estate, New Delhi.

The meeting of Search Committee, comprising of Pr. Secretary (Services), GNCTD as Chairman, Special Secretary (Law, Justice & LA), GNCTD and Additional Secretary (Land & Building Deptt), GNCTD as Members, was held on **27.02.2026 at 11.30 AM** to shortlist applications for the post of Member of the Real Estate Regulatory Authority for NCT of Delhi and UT of Chandigarh.

Total 98 applications were received in response to the advertisement for the post of Member, Real Estate Regulatory Authority for NCT of Delhi and UT of Chandigarh.

The Committee has scrutinized these applications on the basis of eligibility/qualifications stipulated in section 22 of 'The Real Estate (Regulation and Development) Act, 2016', Terms & Conditions and prescribed proforma of application issued at the time of advertisement.

The Committee was of the view that those applications which are complete in all particulars be separated and made as Annexure A. It was apprised to the Committee by the Additional Secretary (Land & Building) that there are some applications in which, either the vigilance clearance certificate is not there or they are not forwarded through proper channel. The Committee of the view that sometimes it is not possible for the applicant to get the certificate within time, therefore, such applications may also be considered and made part of Annexure-A. However, the Selection Committee may take a final decision in the matter. It was also apprised to the Committee by the Addl. Secretary (Land & Building) that some applications are incomplete or are received after due date or are not in the format prescribed by the Department or overage of applicants. The Committee resolved that such application may be separated and be made the part of second Annexure i.e. Annexure-B.



Out of total 98 applications, 85 applications have been shortlisted/found suitable for consideration by the Selection Committee which are enlisted in Annexure-A and 13 applications are not found in order which are enlisted in Annexure-B along with the reasons for not considering them.

The list of shortlisted and rejected applications has been attached herewith as **Annexure-A** and **Annexure-B** for further consideration by the Selection Committee.
