Final ORDER

This order will dispose-off the appeal filed by Shri Raj Kumar Jain in respect of RTI I.D. No.18265.

1. Present Sh. Praveen Kapoor & Sh. V.B Rastogi representing Appellant Sh. Raj Kumar Jain longwith Authority letter on the date of hearing i.e. 21.08.2024.
2. Present Sh. Balveer Kumar Meena, Asstt. Section Officer for PIO/DS (LA).
3. During the hearing, Sh. Praveen Kapoor submitted that he has not received information inspite of lapse of 1 month. Sh. Balveer Kumar Meena, ASO submitted that he has sought information from the PIO(New Delhi) vide letter dated 04.07.2024 in which he has requested to provide the particulars of the letter vide which the proceeding under 5A were sent to the office of the Land & Building department in respect to khasra No. as mentioned in the RTI & appeal. It was further submitted that without the particulars of the letter it is difficult to trace the proceedings held under section 5A hearing. It was further revealed during the course of hearing that an RTI was also filed in the Office of the ADM dated 14.03.2024, where it was informed that detail of the proceedings was sent to the office of the Land & Building. However, no specific particulars were provided so that information can be located in the office of Land & Building. Accordingly, the applicant is advised to approach/appeal the Office of the ADM and obtain the specific details vide which the information of proceedings under section 5A was sent to the office of Land & Building.

In light of the above, this appeal is disposed-off accordingly.

However, if aggrieved with this decision he may file an appeal before the second Appellate Authority within 90 days of receipt of this order.
