Minutes of the meeting of Multidisciplinary Experts Group to evaluate the Social Impact Assessment Report for acquisition of Land in village Taipur Khurd to set up STP.

The Multidisciplinary Expert Group meeting was held under the chairmanship of Additional Chief Secretary (Revenue)-cum-Divisional Commissioner on 14.05.2024 (Tuesday) at 12:00 noon through VC to evaluate the Social Impact Assessment report for acquisition of land measuring 19 Bigha 14 biswa of Revenue Village Tajpur Khurd of District South West for the construction of Sewerage Treatment Plant by the Delhi Jal Board.

- The Group discussed the report and noted that the land in question is 3. essential for setting up the STP for treating the waste water. The SIA report records the assessment of the DJB that the land in question is the best suited for setting up the STP. The report also notes that there is no habitation or cultivation over land to be acquired. As per the SIA report, Sh. Yudhvir Singh and Sh. Lakhvir Singh and the Allied Reality Private Limited are persons/entity whose land rights are affected.

In view of the above, the Group noted that the compensation may be 560/L paid as per the provisions of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and that there is no need for rehabilitation. The Group accordingly recommended that Land Acquisition Collector may take further steps for acquiring the land at the earliest.
