8. Food card/ Election I-Card, 3 passport size photographs and 3 specimen signature duly attested By the Gazetted officer.
9. Affidavit in prescribed format for not owning immovable property in urban area of Delhi has not been submitted. including membership details of Group Housing &
10. Certified copy of Award/ Judgment of ADJ is to be submitted.
11. Sale deed of acquired land in original along with a copy of mutation order in land records has Not been submitted.
12. Any other... Indemnity Bond duly registered with sub-registrar
13. Complete revenue record prior to notification u/s 4 along with status of land not acquired.
