3. The revenue record furnished is not five years prior to issue of notification u/s 4 of L.A. Act.

- ✓ 5. Death certificate of recorded owner at the time of notification u/s 4 of L.A. Act has not been furnished.
- ✓ 6. Legal heir certificate issued by the concerned LAC/SDM has not been submitted.
- ✓ 7. Relinquishment Deed/ Indemnity Bond executed by the other legal heirs of the deceased Recorded owner duly registered with the sub registrar office has not been furnished.
8. Food card/ Election I-Card, 3 passport size photographs and 3 specimen signature duly attested by the Gazetted officer.
- ✓ 9. Affidavit in prescribed format for not owning immovable property in urban area of Delhi has not been submitted. *including membership details of Group Housing*
10. Certified copy of Award/ Judgment of ADJ is to be submitted.
11. Sale deed of acquired land in original along with a copy of mutation order in land records has not been submitted.
- ✓ 12. Any other *Indemnity Bond duly registered with sub-regist*
- ✓ 13. *Complete revenue record prior to notification u/s 4 along with status of land not acquired.*
- ✓ 14. *Ownership proof of H.No. 42 B, Madan Park Punjabi Bagh, New Delhi-42*
