9. Affidavit in prescribed format for not owning immovable property in urban area of Delhi has not been submitted. *including membership details of Group Housing*
10. Certified copy of Award/ Judgment of ADJ is to be submitted.
11. Sale deed of acquired land in original along with a copy of mutation order in land records has Not been submitted.
12. Any other *Indemnity Bond duly registered with sub-regist*

13. Complete revenue record duly attested by the Competent Authority prior to notification u/s-4.
