9. Affidavit in prescribed format for not owning immovable property in urban area of Delhi has not been submitted. including membership details of Group Housing Society
10. Certified copy of Award/ Judgment of ADJ is to be submitted.
11. Sale deed of acquired land in original along with a copy of mutation order in land records has not been submitted.
12. Any other Indemnity Bond duly registered with sub-registrar
13. Complete revenue record prior to notification u/s 4 duly certified by the competent authority.
14. Status of land not acquired.
