6. Legal heir certificate issued by the concerned LAC/SDM has not been submitted.
7. Relinquishment Deed/ Indemnity Bond executed by the other legal heirs of the deceased Recorded owner duly registered with the sub registrar office has not been furnished.
8. Food card/ Election I-Card, 3 passport size photographs and 3 specimen signature duly attested by the Gazetted officer.
- ✓ 9. Affidavit in prescribed format for not owning immovable property in urban area of Delhi has not been submitted. including membership details of Group Housing Society
10. Certified copy of Award/ Judgment of ADJ is to be submitted.
11. Sale deed of acquired land in original along with a copy of mutation order in land records has not been submitted.

- ✓ 13. Payment certificate in r/o Khassan nos 19/17, 16, 24, 25, 24/4, 7/3, 17.
- ✓ 14. Complete Revenue record against Khata Khatauni 77 min and 95 min along with status of land not acquired ie Khatauni
