10. Certified copy of Award/ Judgment of ADJ is to be submitted.
11. Sale deed of acquired land in original along with a copy of mutation order in land records has Not been submitted.

- ✓ 13. *Complete revenue record (Khatoni) prior to notification u/s-4 duly attested by the competent authority along with status of land not acquired.*
