5. Death certificate of recorded owner at the time of notification u/s 4 of L.A. Act has not been furnished.
6. Legal heir certificate issued by the concerned LAC/SDM has not been submitted.
7. Renunciation Deed/ Indemnity Bond executed by the other legal heirs of the deceased if non recorded owner duly registered with the sub registrar office has not been furnished.

- ✓ 9. Affidavit in prescribed format for not owning immovable property in Urban area of Delhi has not been submitted. *Including membership details of Group Housing Society.*

- ✓ 11. Sale deed of acquired land in original along with a copy of mutation order in Urban area has not been submitted.

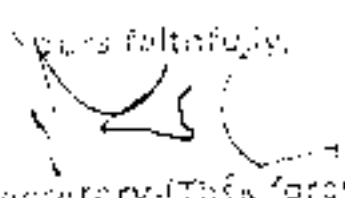
