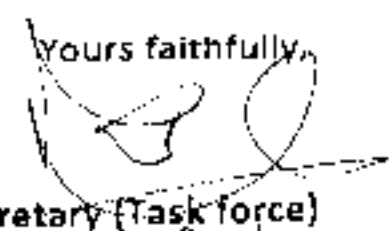

- ✓9. Affidavit in prescribed format for not owning immovable property in Urban area of Delhi has not been submitted. including membership details of Group Housing Societies
