8. Food card/ Election I-Card, 3 passport size photographs and 3 specimen signature duly attested By the Gazetted officer.
9. Affidavit in prescribed format for not owning immovable property in urban area of Delhi has not been submitted. including membership of Group Housing Society
10. Certified copy of Award/ Judgment of ADJ is to be submitted.
