9. Affidavit in prescribed format for not owning immovable property in urban area of Delhi has not Been submitted. *including details of membership of Group Housing Society.*
10. Certified copy of Award/ Judgment of ADJ is to be submitted.
11. Sale deed of acquired land in original along with a copy of mutation order in land records has Not been submitted.
