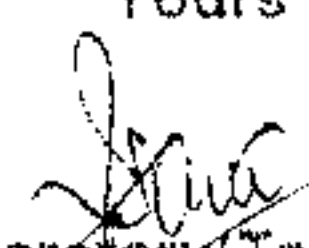
Sir/ Madam,
