12. Indemnity Bond (in original) in favour of President of India through Pr. Secretary (L&B) duly registered with Sub registrar.
13. Status of remaining land.
14. Certified Copy of Award and Statement 'A'.
15. Any other Current status of 1588, Panna Manpur, Area 19, Delhi-110.
