- Death Certificate (in original) of recorded owner at the time of notification U/s 4 of L.A. Act has not been furnished.
- Legal Heir Certificate/Surviving Member Certificate (in original) issued by the concerned L&B SdM has not been submitted.
- Re-purchase Deed (in original) executed by the other legal heirs of the deceased / Recorded Owner duly registered with the Sub Registrar Office has not been furnished.
- Food Card / Election Card / Aadhar Card, 03 Passport size photographs and 03 Specimen Signature duly attested by the Gazetted Officer.
- Affidavit in prescribed format for not owning immovable property in urban area of Delhi including Membership details of Co-Operative Group Housing Society has not been submitted.
- Certified Copy of Judgement of ADJ is to be submitted.
- Sale Deed of acquired land in original along with a copy of Mutation order of land has not been submitted.
