 3. The Complete Revenue Record (in original) to be furnished prior to issue of notification U/s 4 of L.A. Act.
 4. Payment Certificate (in original) in re compensation amount has not been furnished.
 5. Death Certificate (in original) of recorded owner at the time of notification U/s 4 of L.A. Act has not been furnished.
 6. Legal Heir Certificate/Surviving Member Certificate (in original) issued by the concerned Local S.W. has not been submitted.
 7. Allotment Deed (in original) executed by the other legal heirs of the deceased / Recorded Owner duly registered with the Sub Registrar Office has not been furnished.
 8. Photo Card / Election Card / Aadhar Card, 03 Passport size photographs and 03 Specimen signature duly attested by the Gazetted Officer.
 9. Affidavit in prescribed format for not owning immovable property in urban area of Delhi including Membership details of Co-Operative Group Housing Society has not been submitted.
 10. Certified Copy of Judgement of ADJ is to be submitted.
 11. Sale Deed of acquired land in original along with a copy of Mutation order of land has not been submitted.
 12. Indemnity Bond (in original) in favour of President of India through Pr. Secretary (L&B) duly registered with Sub registrar.
 13. Status of remaining land.
 14. Certified Copy of Award and Statement 'A'.
