7. Relinquishment Deed (in original) executed by the other legal heirs of the deceased / Record of Rights duly registered with the Sub Registrar Office has not been furnished.
8. Food Card / Election Card / Aadhar Card, 03 Passport size photographs and 03 Specimen Signatures duly attested by the Gazetted Officer.
9. Affidavit in prescribed format for not owning immovable property in urban area of Delhi including Membership details of Co-Operative Group Housing Society has not been submitted.
