12. Indemnity Bond (in original) in favour of President of India through Pr. Secretary (L&B) duly registered with Sub registrar.

14. Certified Copy of Award and Statement 'A'.
15. Any other Ownership status of P-6, Gali No-1, Pana Udyan, Narela, Delhi.
