6. Legal Heir Certificate/Surviving Member Certificate (in original) issued by the concerned LAC/SDM has not been submitted.
7. Redemptions Deed (in original) executed by the other legal heirs of the deceased / Recorded Owner duly registered with the Sub Registrar Office has not been furnished.
8. Photo Card / Election Card / Aadhar Card, 03 Passport size photographs and 03 Specimen signature duly attested by the Gazetted Officer.
